LEADERSHIP OF THE REGIONAL HOUSE OF REPRESENTATIVES OF THE
REGENCY OF SUKOHARJO,

- Considering : a. that with the inauguration of Members of the Regional House Of Representatives of the Regency of Sukoharjo for the 2019-2024 Term of Office and to realize the efficiency, effectiveness, productivity, and accountability of regional governance through the implementation of the rights, obligations, duties, authority, and functions of the Regional House of Representatives in accordance with the provisions of legislation, the Regulation of the Regional House Of Representatives of the Regency of Sukoharjo Number 1 of 2018 on Rules of Procedure of the Regional House of Representatives of the Regency of Sukoharjo the Regional House of the Regency of Sukoharjo needs to be amended;
- b. that based on the consideration as referred to in point a, it is necessary to issue a Regulation of the Regional House of the Regency of Sukoharjo on Amendment to Regulation of the Regional House of Representatives of the Regency of Sukoharjo Number 1 of 2018 on Rules of Procedure of the Regional House of the Regency of Sukoharjo;

HAS DECIDED:

To Issue : AMENDMENT TO REGULATION OF THE REGIONAL HOUSE OF THE REGENCY OF SUKOHARJO NUMBER 1 OF 2018 ON RULES OF PROCEDURE OF THE REGIONAL HOUSE OF THE REGENCY OF SUKOHARJO.

Article I

Several provisions in the Regulation of the Regional House of the Regency of Sukoharjo Number 1 of 2018 on Rules of Procedure of the Regional House of the Regency of Sukoharjo (Regional Bulletin of the Regency of Sukoharjo of 2018 Number 57), are amended as follows:

1. The provisions of section (4) of Article 50 are amended and 1 (one) new section is inserted between section (5) and section (6), namely section (5a), so that it reads as follows:

Article 50

- (1) Every Member of DPRD, except the Leadership of DPRD, becomes a member of one of the commissions.
- (2) The number of commissions is established in accordance with the Law on Local Governments.

- (3) The number of members of each commission is determined by considering the balanced and equitable distribution of the number of members between commissions.
 - (4) The number of Commission Members as referred to in section (3) comprises as follows:
 - a. Commission I : 9 (nine) persons
 - b. Commission II : 11 (eleven) persons
 - c. Commission III : 11 (eleven) persons
 - d. Commission IV : 10 (ten) persons
 - (5) Membership in a commission is decided in a plenary meeting on the proposal of a faction at the beginning of the fiscal year.
 - (5a) The proposed number of members of a faction who will sit on each commission is determined by the Leadership of DPRD by considering the balanced and equitable distribution of the number of members between factions.
 - (6) The chairperson, vice chairperson, and secretary of a commission are elected from and by the members of the commission and reported in a plenary meeting.
 - (7) The term of office of the chairperson, vice chairperson, and secretary of a commission is 2 (two) years and 6 (six) months.
 - (8) In the event that there is a replacement of the chairperson, vice chairperson, and/or secretary of the commission, re-election of the chairperson, vice chairperson, and/or secretary of the commission as referred to in section (5) is conducted.
 - (9) The term of office of a replacement chairperson, vice chairperson, and/or secretary of a commission continue the remaining term of office of the person being replaced.
 - (10) The transfer of DPRD Members between commissions can be carried out after their membership period in the commission is at least 1 (one) year based on the proposal of a Faction.
2. The provisions of point b of Article 100 are amended to read as follows:

Article 100

Work clothes of DPRD :

- a. in attending plenary meetings, leaders and members of the DPRD will wear:
 - 1) Daily Civilian Clothes (*Pakaian Sipil Harian*, PSH) in the event that the meeting will not take a decision of the DPRD;
 - 2) Official Civilian Clothes (*Pakaian Sipil Resmi*, PSR) in the event that the meeting will take a decision of the DPRD.
- b. in attending the Plenary Meeting of the Oath/Promise of Members of DPRD, the Plenary Meeting of the Oath/Promise of DPRD Leadership, the Plenary Meeting of the Oath/Promise of Interim Replacements, the Plenary Meeting of Submission of DPRD Recommendations on the Regent's LKPJ and the Plenary Meeting to Listen to the State Speech of the President of the Republic of Indonesia in the Context of the Independence Day of the Republic of

Indonesia, the leadership and members of DPRD will wear Complete Civilian Clothes (PSL) with National *Peci* for men and National dress for women.

- c. in conducting work visits or field observations, leaders and members of DPRD shall wear Daily Service Clothes (*Pakaian Dinas Harian*, PDH)/batik.
- d. in certain events, leadership and members of DPRD may wear traditional dresses.
- e. in addition to the provisions as referred to in point a, point b, point c, and point d, on ordinary days the following provisions apply: Monday to Wednesday: Neat casual clothes Thursday and Friday: Batik clothes.

Article II

This DPRD Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this DPRD Regulation by its placement in the Regional Gazette of the Regency of Sukoharjo.
