REGIONAL REGULATION FORMATION PROGRAM SUKOHARJO DISTRICT IN 2025

LEADERSHIP OF THE SUKOHARJO REGENCY PEOPLE'S REPRESENTATIVE COUNCIL,

Considering

- a. that the planning for the preparation of Regional Regulations is carried out in the Regional Regulation Formation Program as referred to in the provisions of Article 39 of Law Number 12 of 2011 concerning the Formation of Legislation as amended several times last by Law Number 13 of 2022 concerning the Second Amendment to Law Number 12 of 2011 concerning the Formation of Legislation;
- b. that based on the provisions of Article 37 paragraph (2) of Law Number 12 of 2011 concerning the Formation of Legislation as amended several times last by Law Number 13 of 2022 concerning the Second Amendment to Law Number 12 of 2011 concerning the Formation of Legislation, the Regional Regulation Formation Program is stipulated by a Decree of the Regional House of Representatives;
- c. that based on the considerations as referred to in letters a and b, it is necessary to stipulate a Decree of the Sukoharjo Regency Regional House of Representatives concerning the Program for the Formation of Regional Regulations for Sukoharjo Regency in 2025.
